



SWIMMING POOL RULES FOR WOODLYN MEADOW PHASE I & II

1. Swimming pool hours will be as posted on the pool house.
2. Children (both resident & guests): 14 YEARS OF AGE AND UNDER MUST BE ACCOMPANIED AT ALL TIMES BY AN ADULT*. RESPONSIBLE PERSON MUST REMAIN IN POOL AREA WITH CHILDREN.
3. All swimmers must shower before entering pool.
4. No glass containers are allowed in pool area.
5. Trash must be deposited in receptacles.
6. Swimmers with infectious skin diseases are not allowed in pool.
7. Running or rough play is NOT allowed.
8. Foul language or obscene gestures are NOT allowed.
9. No pets allowed in pool area.
10. Ball playing or other games that interfere with another must cease upon request.
11. Swimsuits only in pool. No Cut-offs, shirts, shorts, or other non-swimming apparel allowed in pool.
12. No furniture is to be removed from the pool area.
13. Property Owners will be held responsible for actions of their guests.
14. Anyone caught climbing over the fence to enter the pool or any member who brings a person to the pool under false pretenses will have pool privileges suspended.
15. Sliding down handrails or ladders is NOT permitted.
16. Child flotation devices are permitted; however, rafts or floating chairs are NOT allowed.
17. No device of any kind which could move or otherwise transport a person, whether by land or water, including but not limited to wheeled toys such as bicycles, remote controlled cars, skateboards, etc. are NOT allowed.
18. Infants must wear appropriate swim apparel. NO diapers allowed.
19. Cigarette butts and other tobacco products must be disposed of properly.
20. NO DIVING, head-first jumping, cannon ball jumping, or other conduct that may cause undue splashing of other pool patrons is allowed.
21. Additional posted rules on the pool house must be adhered to.
22. Pool swipe cards are required to access the pool area. There is a \$100.00 replacement for lost or stolen cards.
23. Failure to abide by the rules may result in the following consequences: Warning, suspension of pool privileges, monetary fine.
24. Adult guests of Woodlyn Meadow I & II may use the pool unaccompanied by residents as long as they possess the swipe card while in the pool area.
25. PROVIDING ANY UNAUTHORIZED PERSON (NON-MEMBER OF WOODLYN MEADOW PHASE I & II) ENTRY TO THE POOL, WILL RESULT IN POOL PRIVILEGES BEING SUSPENDED.
26. NON-PAYMENT OF DUES WILL ALSO RESULT IN SUSPENSION OF POOL PRIVILEGES.

*Adult is a person 18 years of age or older

*THE POOL IS FOR THE SOLE USE OF RESIDENTS OF WOODLYN MEADOW PHASE I & II, AND INVITED GUESTS ONLY
